



## **New York Health & Racquet Club Membership Information Fact Sheet**

*We recognize the success of New York Health & Racquet Club is due largely to the loyalty of our members and we are committed to doing everything in our power to make this transition as seamless as possible. The following information is intended to provide clarity on membership access moving forward.*

The following NYHRC locations will gradually transition to Life Time HRC:

- Cooper Square
- 21<sup>st</sup> St.
- 23<sup>rd</sup> St. (renovation in progress)
- 56<sup>th</sup> St.

***As we previously shared with you in July regarding our collaboration with Life Time, your home club, our Cooper Square location will be transitioning to a Life Time HRC club. The Cooper Square location will be closing for renovations on December 1, 2019.***

The remaining three locations will each continue to be operated by NYHRC as a NYHRC club until renovations commence over the next 12 months, and each is transitioned to a Life Time HRC location. The length of location closures will vary from location to location.

Announcements for the remaining two clubs will be made in advance so that members have an opportunity to review their options and plan accordingly.

The following locations will remain NYHRC Clubs:

- Whitehall
- 45<sup>th</sup> St.
- 13<sup>th</sup> St.
- 76<sup>th</sup> St.

### **Members with a home club assignment to one of the continuing NYHRC locations (Whitehall, 45<sup>th</sup> St., 13<sup>th</sup> St., 76<sup>th</sup> St.)**

- With respect to a member who is a home club member of Whitehall, 45<sup>th</sup> St., 13<sup>th</sup> St., or 76<sup>th</sup> St. the member's membership with their current NYHRC club location will not be affected and will continue.
- A NYHRC member with a home club assignment of Whitehall, 45<sup>th</sup> St., 13<sup>th</sup> St., or 76<sup>th</sup> St. will have the option to purchase daily guest passes at a 33% discount to any Life



Time club including the Cooper Square, 21<sup>st</sup> St., 23<sup>rd</sup> St., 56<sup>th</sup> St. locations when opened by Life Time as Life Time HRC clubs; provided such member remains a NYHRC member. Life Time and NYHRC may agree to terminate such privileges without consent of the member. Such privileges may also terminate under certain circumstances agreed upon by NYHRC and Life Time. NYHRC shall provide notice if such privileges will terminate.

**Members with a home club assignment of Cooper Square or one of the future Life Time HRC locations (21<sup>st</sup> St., 56<sup>th</sup> St., 23<sup>rd</sup> St.)**

\*Committed term - any monthly billing (EFT) member that is still within a commitment period or a paid-in-full member with a future expiration date.

- Due to the inconvenience of the transition, all members with home clubs that are impacted by this announcement (Cooper Square, 21<sup>st</sup> St., and 56<sup>th</sup> St.) with paid-in-full or monthly billing (EFT) committed memberships will receive an additional two months added to their membership. Corporate members will receive 2 complimentary months when possible, dependent on their company's current program with NYHRC.
- After the closure of the NYHRC clubs located at Cooper Square, 21<sup>st</sup> St., and 56<sup>th</sup> St., home club members of each of these locations, within a monthly billing committed term or paid-in-full membership, can continue their membership with the continuing NYHRC locations (Whitehall, 45<sup>th</sup> St., 13<sup>th</sup> St., 76<sup>th</sup> St.).
- Home club members of Cooper Square, 21<sup>st</sup> St., and 56<sup>th</sup> St. locations that currently have access to only one club location and decide to continue their membership with NYHRC will be upgraded to an All Access NYHRC membership when their home location closes, which will grant them access to all of the then continuing NYHRC locations.
- Home club members of Cooper Square, 21<sup>st</sup> St., and 56<sup>th</sup> St. locations may alternatively choose, after their home club closes, to sign a new membership agreement with Life Time so that they can access their Life Time HRC location of choice once it is reopened. Once their chosen Life Time HRC club reopens, Life Time will, as a goodwill gesture, either honor the time remaining on their committed term (not to exceed 12 months) provided they continue to pay the committed monthly dues amount to Life Time or honor the time remaining on their prepaid period, as applicable.



- Life Time will also honor the greater of any earned NYHRC tenured months or the 2 months of complimentary membership (if any awarded by NYHRC). If this option is elected, they would be required to sign Life Time's membership documents (set to activate upon their chosen Life Time club's reopening) and must simultaneously terminate their NYHRC membership agreement.
- Once their chosen Life Time HRC club opens, their honored access period described above will begin, after which all standard Life Time membership rates and provisions will apply. Corporate members may receive 2 complimentary months when possible, dependent on their company's current program with NYHRC.
- Members who choose to sign an agreement with Life Time and terminate their NYHRC membership will also, once their Life Time membership is activated, have access to all clubs nationwide that are operated by Life Time and their affiliates until their honored access period expires.
